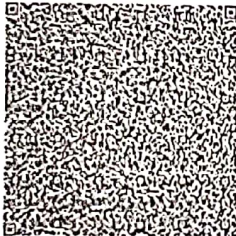


**RECITALS**
